
Online Applications are invited from eligible Male & Female Indian citizens (including subject of Nepal & Bhutan) for filling up following vacancies to the post of **Sub Inspector (Hindi Translator)** of General Central Service Group 'B' Non-Gazetted (Non-Ministerial) on temporary basis likely to be permanent in the Indo-Tibetan Border Police Force (ITBPF). The post has all India liability and selected candidates will be liable to serve anywhere in India or abroad. On appointment, the candidates shall be governed by the ITBPF Act, 1992 and ITBPF Rules, 1994 and other Rules applicable from time to time. Applications from candidates will be accepted through **ONLINE MODE** only. No other mode for submission of application is allowed. **ONLINE APPLICATION MODE WILL BE OPENED W.E.F. 28<sup>TH</sup> JULY, 2024 (28/07/2024) AT 00:01 AM AND WILL BE CLOSED ON 26<sup>TH</sup> AUGUST, 2024 (26/08/2024) AT 11:59 PM.** The applicants are advised to check their eligibility before applying, so as to avoid disappointment at a later stage.

- (3) 10% vacancies are reserved for Ex-Servicemen. In case vacancy reserved for Ex-servicemen remains unfilled due to non-availability of eligible or qualified candidates, the same shall be filled by non Ex-serviceman candidates of respective categories.



(4) As per MHA guidelines, if a situation so arises wherein the women candidates in the horizontal compartmentalized reservation in any of the vertical reservation categories are not available, then the posts shall be filled up from amongst the male candidates from the concerned vertical reservation categories.

#### 5. HOW TO APPLY AND BY WHICH DATE:

a)	Eligible and interested candidates need to apply online through ITBPF website <a href="https://recruitment.itbpolice.nic.in">https://recruitment.itbpolice.nic.in</a> . Candidates are advised to fill the online application form after reading the instructions carefully and should provide genuine and functional e-mail ID and Mobile number at the time of filling online application form. Details as required under various segments should be mentioned clearly, correctly and logically. As the applications need to be submitted online only, applications received offline shall not be considered and will be rejected summarily.
b)	Candidates are to fill all information e.g. Gender/Category (UR/SC/ST/OBC (NCL)/EWS etc), Employment status/Riots affected, etc. in the profile created on ITBP recruitment website before submission of online application. Any false/incorrect information in online application will lead to cancellation of candidature and no request for change in such details will be considered at later stages.
c)	<b>APPLICATION FEE &amp; MODE OF PAYMENT-</b> Male candidates belonging to UR, OBC and EWS category applying for this recruitment will have to pay <b>Rs. 200/- (Rupees Two hundred only)</b> as application fee through the online payment gateway system on <a href="https://recruitment.itbpolice.nic.in">https://recruitment.itbpolice.nic.in</a> . Application received with any other mode of fee payment will be summarily rejected. <b>Candidates belonging to Scheduled Caste, Scheduled Tribe, Females and Ex-servicemen are exempted from paying the fee.</b>  <b>Note:-</b> i) Fee once paid will not be refunded under any circumstances.  ii) Fee paid by modes other than online mode will not be accepted and the applications of such candidate will be rejected forthright. Besides above, the payment made in such cases shall stand forfeited.

d)	Candidates working in Central/State Government/ Autonomous/ Statutory Bodies/ Public Sector Undertaking etc. applied to the post are required to furnish "No Objection Certificate" in original as per Annexure-IV issued by the employer at the time of verification of documents. g)	Candidates are strongly advised to apply well in time without waiting for the last date for submission of online application form.

6. **SELECTION PROCESS:**

- a) Admit Cards to the candidates will be issued online mentioning the date and venue of recruitment test. Candidature of candidates who are issued online admit cards will remain provisional till they are finally selected and submit all related documents/certificates in original and in prescribed format at the stage of verification of original documents.
- b) **Candidates are required to bring a clear & legible print out of their online application form & admit card; else they will not be permitted to enter the venue of Physical Efficiency Test (PET) & Physical Standard Test (PST).**

**Note:-**

- (i) Before start of PET & PST, the candidates will undergo thorough verification of identity including Biometric capture.
- (ii) Biometric identification of candidates can also be verified at any stage of recruitment.
- (iii) It is candidate's responsibility to check before hand that the biometric machines are able to capture the fingerprint image. In case, if the biometric machine is not able to capture the fingerprint image due to Mehndi, wax, etc. then, the candidate will not be allowed to appear in the examination.
- (iv) Failure in biometric verification at any stage will lead to cancellation of candidature.



<b>PHASE - I</b>

Candidates have to qualify each event of PET, those who do not qualify shall be eliminated.</p> <p>(iii) On reporting of female candidates for Physical Efficiency Test (PET) &amp; Physical Standard Test (PST), a self declaration indicating about her pregnancy status shall be submitted. In case, if she declares that she is not pregnant then, she may be allowed to participate in the PET/PST. In case of false declaration, all the risk for undergoing PET/PST will be of her own.</p> <p>(iv) If, the female candidate declares that she is pregnant before PET/PST, then a confirmatory pregnancy test to be done and in case she is found to be pregnant, irrespective of duration of pregnancy; she may be declared temporary unfit and her appointment shall be held in abeyance until the confinement is over. However, female candidate who are declared temporary unfit will require to appear and qualify in remaining stages of recruitment i.e. PST, Written Examination, Documentation and Medical Examination. The vacancy against which a women candidate was selected will be kept reserved for her. She will be re-examined for Physical Standard Test (PST)/Physical Efficiency Test (PET) six weeks after the date of confinement, subject to the production of the medical certificate of fitness from a registered medical practitioner. If she is found fit, she may be appointed to the post kept reserved for and allow the benefit of seniority in accordance with the instructions of the Government, as amended from time to time. 	<p><b>Note:-</b> PET will not be held for Ex-servicemen. However, they require to qualify the requisite PST, Written Examination, Documentation and Medical Examination.</p>
PHYSICAL STANDARD TEST (PST)	<p>(i) Candidates who qualify in PET will be screened for Height, Weight and Chest measurement (Chest measurement for male candidates only). Those who do not meet the required physical measurements, as applicable will be eliminated at that stage and rejection slip shall be issued by the Presiding Officer.</p> <p>(ii) Physical Standard of female candidates shall be measured by female staff only. Chest measurement of female candidates should not be taken. Besides, in case of female pregnant candidates shall be dealt as per instructions issued by the Central Government for PET/PST stage.</p> <p>(iii) Candidates who fail to qualify PST shall be eliminated from that stage and rejection slip shall be issued by the Presiding Officer.</p> <p>(iv) Rejection slip for less in height and chest will be issued at the time of PST. Board shall ensure that measurement is mentioned in writing in the rejection slip. In case, if candidate is not satisfied with the physical measurement recorded by the Board, he/she may make a representation/appeal in writing to the Presiding Officer of the Recruitment Board on the same day for re-measurement. The final decision on fitness/unfitness due to underweight/overweight will be decided at the time of Detailed Medical Examination (DME) based on the weight and age on the day of DME and the height as measured by the PST Board.</p> <p>(vi) The decision of the Presiding Officer will be final and no further appeal or representation in this regard will be entertained</p>





thereafter. There is no provision of appeal for Physical Efficiency Test (PET).

**Note:-** PET will not be held for Ex-servicemen. However, Ex-servicemen will be required to qualify the requisite PST, Written Examination, Documentation and Medical Examination.

**PHASE - II**

Written Examination (200 marks)

(i) The candidates who qualify in Physical Standard Test (PST) will be required to undergo written examination. Admit cards to the candidates, will be issued online by mentioning date and venue of the written Examination. Candidates have to download online admit card from ITBPF recruitment website i.e. [www.recruitment.itbpolice.nic.in](http://www.recruitment.itbpolice.nic.in).

(ii) The written examination carrying 200 marks. However, pattern of written test i.e. OMR based or Computer Based Test (CBT) will be at the discretion of ITBPF. The pattern of question paper of written examination will be as under :-

iii) Answer Key of the question paper will be uploaded on ITBPF recruitment website i.e. <https://recruitment.itbpolice.nic.in> after the written examination is completed.

iv) Candidates are not permitted to use electronic gadgets including Mobile Phones, calculators or any other electronic/electrical device. Possession of these items, whether in use or not, will be considered as "use of unfair means" in the examination and appropriate action will be taken against such candidates.




	<p>v) The minimum cut-off percentage of marks for qualifying in written examination will be as follows:-</p> <p>UR/EWS/Ex-servicemen candidates : 35 % SC/ST/OBC (NCL) candidates : 33%</p> <p>vi) Candidates found copying or using any unfair means should be disqualified and debarred from further test. An endorsement also be made in all such confiscated answer sheets by the Board/Observer to this effect.</p> <p>iii) No representation for revaluation of answer sheet of written examination or re-conduct of written examination will be entertained.</p>
MERIT LIST	<p>(i) After completion of written examination, Merit list in each category, namely UR, SC, ST, OBC (NCL), EWS and Ex-servicemen will be drawn on the basis of marks obtained by the candidates in the written examination. On the basis of merit, the candidates shall be shortlisted for Verification of original documents and Detailed Medical Examination (DME) as per the category-wise vacancies. The number of candidates examined will be equal to the number of vacancies increased by average failure rate of DME/RME determined on the basis of past experience. <b>However, there shall be no reserve list.</b></p> <p>(ii) SC, ST, OBC (NCL) &amp; EWS candidates who are selected on their own merit without relaxed standards will not be adjusted against the reserved share of vacancies. Such SC, ST, OBC (NCL) &amp; EWS candidates shall be accommodated against the General vacancies as per their position in overall merit list.
